BACK IN THE GOOD OLE DAYS (6 MONTHS AGO)

- \$93.2 Billion for 2020-2021(July 1)
- \$2.2B more than last year
- \$500M for teacher raises
- 3% state employee raises
- 3518 bills filed
- 210 bills passed

BACK IN THE GOOD OLE DAYS (6 MONTHS AGO)

- Created reserves of approximately \$5B (COVID impact unknown at the time)
- Budget was built on pre-COVID revenue estimates
- No adjustments we necessary for the budget year ending June 30, 2020

BACK IN THE GOOD OLE DAYS (6 MONTHS AGO)

- Economy shut down
- School buildings closed
- Virtual instruction the norm
- Last week of session impacted
- That was then.....
- This Is Now.....

OCTOBER 2020

- Historic and controversial presidential election one month away
- Election/voting issues
- SCOTUS TV ads
- Florida and U.S. partially reopened

OCTOBER 2020

- Florida faces a \$5.4 Billion budget shortfall over next two years
- **\$3.4B** for 2020-21
- **\$2B** for 2021-22
- Being offset with reserves and CARES \$\$

OCTOBER 2020

Governor DeSantis said on a radio show Monday that the pandemic will "loom" over every budget and policy debate during the 2021 legislative session, which starts in March.

- Amendment 1: Citizenship Requirements to Vote in Florida Elections
- Changes language from "every citizen of the United States can Vote to "only citizens of the United States can vote.

- Amendment 2: Raising Florida's minimum wage
- Would raise minimum wage to \$15 per hour by 2026.
 Current rate is \$8.56 in Florida and \$7.25 federal

- Amendment 3: All Voters
 Vote in Primary Elections for
 State Legislature, Governor
 and Cabinet
- Currently closed primaries.
 Amendment advocates
 "jungle primary;" two highest vote-getters advance to general election

- Amendment 4: VoterApproval of ConstitutionalAmendments
- Voter ballot initiatives would need to get 60% approval in TWO separate elections instead of the current ONE election

- Amendment 5: Limitations on Homestead Assessments (originated in the legislature)
- This would give homeowners an additional year (3 instead of 2) to claim the tax benefit of Homestead Exemption for those moving from one homestead property to another.

- Amendment 6: Ad Valorem Tax Discount for Spouses of Certain Deceased Veterans Who Had Permanent, Combat-related disabilities (originated in the legislature)
- Allows eligible spouses to claim an existing property tax exemption after the death of the veteran.

THE REST OF 2020

- A chaotic 3 months
- Likely no special session
- Education systems in flux
- Uncertain economic recovery
- Continued budget shortfalls
- Unemployment unstable
- Vaccine??

- Competition for limited resources
- Potentially contentious legislative session
- The state budget
